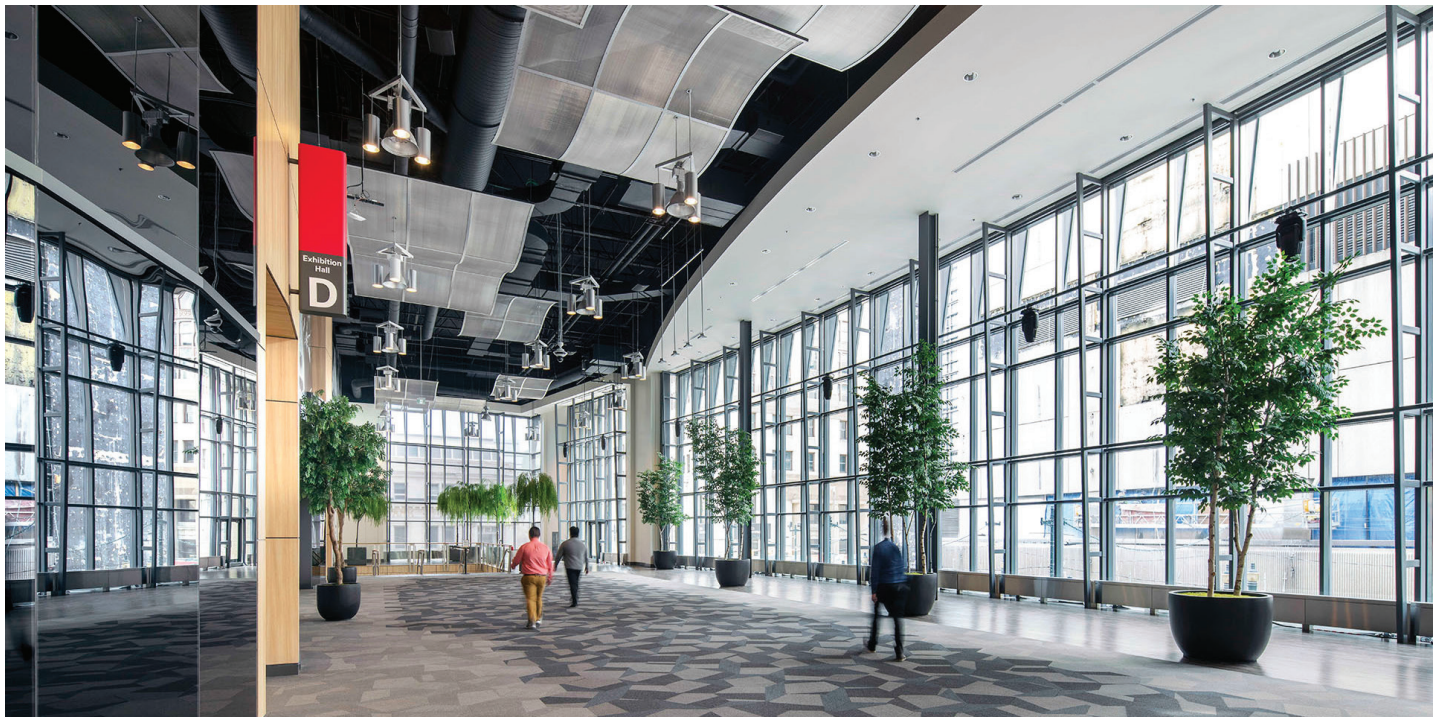

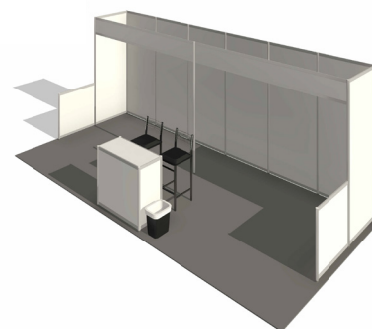
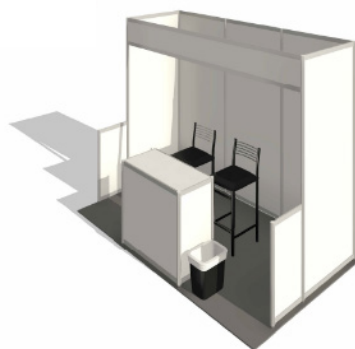

Pricing, Production Deadlines & Benefits

All pricing listed is quoted in CAD Dollars. All inclusions in Conference design and print materials are subject to strict production deadlines. **Sponsor and exhibitor benefits will not be implemented until payment has been received in full.**

How to Apply

To book your participation at GHGT-17, either as a sponsor or as an exhibitor, please go to the online booking platform and complete the application form. All applications received will be acknowledged in writing together with an invoice complete with payment details to facilitate payment. Submission of an application indicates your acceptance of the full terms and conditions as shown on the booking platform and as stated within these terms and conditions. Sponsorship and exhibition allocation will be determined, on a first-come first-served basis, in order of received applications and fully paid booking fees. The Organizer reserves the right to accept or decline any application in its sole discretion.

Confirmation of Participation / Payment Schedule

Submission of your application will be confirmed in writing and an accompanying invoice will be provided. To hold your position, a minimum 50% deposit is required to be paid within 30 days of receipt of your application confirmation. To finalize your selection, payment of all remaining booking fees must be made in full by close of business on April 30, 2024 (the "Due Date") - failure to do so will result in your sponsorship item or exhibition stand being released for resale. Payment of booking fees may be made by cheque, bank transfer (subject to a \$20 surcharge per transfer), or credit card (subject to a 5% surcharge). Details of payment options are included on your invoice.

Cancellation Policy

All cancellation requests must be submitted in writing to Venue West Conference Services Ltd. (the "GHGT-17 Conference Secretariat"). Cancellation requests received on or before April 30, 2024, will receive a full refund, less a 15% cancellation fee calculated based on the full value of the sponsor/exhibitor booking fee that is required for participation at the Conference. Cancellations received after that date, are not eligible for a refund of any kind. If the balance of the booking fee payment is not received by the Due Date, the allocated sponsorship or exhibition booth space will be cancelled and released for resale. Any changes in the duration and/or location of the Conference, as determined by the Organizer (Emissions Reduction Alberta in conjunction with the GHGT-17 Conference Secretariat) in its sole discretion, will not entitle the sponsor/exhibitor to cancel their participation, request a refund of any fees, or advance a claim for any type of damages.

Cancellation of the Conference

The Organizer is entitled to cancel the Conference due to reasons beyond their control that prevent or substantially hinder the planned holding of the Conference. If the Organizer is compelled to cancel the Conference for reasons beyond their control and a subsequent Conference is not organized in its place within twelve (12) months of the originally planned date, the sponsor/exhibitor is released from its obligations and will receive a full refund of any booking fees paid. In the event the Conference is required to be a Virtual Only Conference both sponsorships and exhibitors will be transferred to the Virtual Conference.

Sponsorship

Priority amongst sponsors within the same sponsorship tier will be determined based on the order of receipt of full booking fee payment (not merely the deposit). Priority between sponsors of the same tier, applies to, amongst other things, exhibition booth allocation and exclusive sponsorship options. Sponsors acknowledge and agree that through sponsorship participation, the sponsor is partially supporting the financing of the Conference. In return, the sponsor will receive the opportunity to reasonably present their endeavours, products, and findings within the scope of the Conference.

Booth Allocation

An application for exhibit space will be considered finalized upon full payment of booking fees. Thereafter, booth allocation will be determined in conjunction with the completion of an online exhibitor form. Changes in booth allocation without the explicit written consent of the Organizer will not be permitted. Exhibitors desiring to share their contracted exhibition space with another company will face a surcharge and such an arrangement is subject to prior written approval by the Organizer.

Exhibitor Protocol

Each exhibitor must always keep their display within the dimensions of their exhibition booth during the Conference and refrain from amplified announcements or music from their exhibition display. Nothing shall be taped, mounted, or attached in any form or manner to walls, doors, or facility structure. The driving of nails, tacks, or screws into floors, walls, columns, ceiling, or trim will not be permitted nor will be the drilling of holes into any portion of the venue.

Sponsor Registration

In connection with your Sponsorship package, you will be required to complete an online registration form with the details of the attending delegate(s) before June 1, 2024. Registration will be available online and a link will be provided. Full registration includes access to all Conference amenities, sessions, the exhibition, and the Welcome Reception. Badges will be available for pick up at the Conference registration desk. Name badges must be worn at all times.

Hotel Accommodation

Room bookings at the Conference hotels can be made via the sponsor/exhibitor registration site. The link will be provided once a package is confirmed and booking fees are paid in full.

Related Events

Sponsors and exhibitors should not arrange competing events against any of the Conference functions or sessions and are required to provide the GHGT-17 Conference Secretariat with information regarding their proposed booth and social activities.

Delegate Lists

Due to privacy laws, some delegates have chosen to have their personal information excluded from the delegate list that is provided to sponsors/exhibitors. Exhibitors may attempt to collect contact information within the confines of their booth.

Fire, Safety and Health

All Conference participants are fully responsible for compliance with all applicable municipal, provincial, and federal fire, safety, and health regulations, including but not limited to rules and regulations regarding the installation, operation, and dismantling of display material and equipment, or otherwise relating to their participation at the Conference or the particulars of their booth.

Insurance

Exhibitors are required, at their sole cost and expense, to procure and maintain comprehensive general liability insurance against claims for bodily injury or death and property loss, theft, or damage, occurring prior to, during, and after the Conference for a minimum amount of 1 million dollars. A copy must be forwarded to the Conference Secretariat one month prior to the event.

Liability

Persons attending the Conference assume all responsibility associated with risk of damage, personal injury, or loss resulting from, or arising in connection with, their involvement at the Conference, including but not limited to, the showing, viewing, or presenting of exhibits. Each person attending the Conference has the sole responsibility for its property including any claims related to theft, damage, or other loss, including any subrogation claims by its insurer.

The Climate Change and Emissions Management (CCEMC) Corporation o/a Emissions Reduction Alberta, Venue West Conference Services Ltd., The Calgary Convention Centre Authority and the official show contractor, their affiliates and their respective officers, directors, members, managers, representatives, subcontractors, agents and employees (collectively the "Released Parties") shall not be liable to any sponsor, exhibitor, Conference attendee, or any other person or entity (collectively a "Participant") for any direct, incidental, consequential, exemplary, punitive or special losses or damages, arising directly from or in relation to their involvement or participation in the Conference, including loss of future profits, loss of goodwill and costs associated to damaged property, or any other losses, damages or expenses whether arising out of breach of contract, tort (including negligence), extra-contractual liability or otherwise, regardless of whether such damage or loss was foreseeable and whether or not the Released Parties were advised of the possibility of such damage or loss.

Indemnity

Each Participant shall defend, indemnify and hold the Released Parties harmless from and against all claims, suits, demands, losses, liabilities, damages (including injury and death) and expenses (including reasonable attorneys' fees and the costs of enforcing any right to indemnification hereunder and the costs of pursuing any insurance providers or other sources of recovery) resulting from, or arising in connection with, their involvement or participation at the Conference.
